**Mandate #5**

**THIS MANDATE SUPERCEDES ALL LOCAL MANDATES PRIOR TO MAY 26, 2020  
AND WILL BE RE-EVALUATED ON JUNE 4, 2020.**

**EMERGENCY ORDERS TO PROTECT THE HEALTH AND SAFETY OF THE  
RESIDENTS OF QUINHAGAK, ALASKA DURING THE COVID-19 PANDEMIC**


The Native Village of Kwinhagak IRA Council (NVK) met to establish protocol effective March 23, 2020 (Updated April 7, 2020) (Updated May 7, 2020) (Updated May 20, 2020) (Updated May 26, 2020) until June 15, 2020 to ensure the health and safety of the residents of Quinhagak, Alaska during the COVID-19 pandemic and have established the following mandates:


1. Air and land travel by non-residents into Quinhagak, AK is suspended until June 15, 2020.
2. Residents must cease all non-essential travel out of the community and limit travel to essential travel for medical related or emergency purposes or for work/training/education.
3. Only emergency and essential public service personnel will be allowed entry into the community.
4. Individuals traveling to/from Quinhagak, AK will be required to get a written permission from Native Village of Kwinhagak.
5. Individuals returning to Quinhagak, AK will be required for COVID-19 test upon arrival and are subject to a 7-day self-quarantine with all members of household or until test results is determined to be negative. 14-day self-quarantine with members of household if not tested.
6. Residents will follow the guidelines for COVID-19 issued by this Local Emergency Order, the State of Alaska and the United States Government.
7. All residents will honor the safety measures implemented by all organizations.

**The Native Village of Kwinhagak IRA Council, puts the health and safety of its community residents as a priority above all else and desires to put precautions in place to prevent the entry and transmission of the COVID-19.**

**The Native Village of Kwinhagak IRA Council will put a priority on enforcement of this mandate to prevent the transmission of COVID-19 and failure to abide by the local, state and federal guidelines may result in criminal charges and fines.**

**CERTIFICATION:** This certifies that this mandate was duly adopted at a formally convened NVK meeting of the Native Village of Kwinhagak IRA Council, at which time a quorum was present. This mandate was adopted/updated by a vote of 6 for, 0 against, with 0 abstaining on this 26<sup>th</sup> day of May 2020.
