**Precautionary Action for Native Village of Tuntutuliak
EFFECTIVE 03-19-2020
(Amended 05/05/2020)**

1. Travelers from Anchorage:
 - a. All travel for non-community members coming into the Native Village of Tuntutuliak is still suspended for persons traveling in from Anchorage including travelers from the surrounding villages and outside the State of Alaska (non-business travels as well as business travels) until further notice.

Pass Through Travelers:

- a. All pass through travel by boat from the surrounding villages including Bethel is now allowed as of May 5, 2020. Qinarmiut Gas Station will not be selling gasoline to surrounding village travelers until further notice.
- b. Other surrounding villages including Bethel can now come into to the community but will have to wear face masks when going to public places.
- c. We are now allowing customers from other surrounding villages to go to the the stores but must wear face masks.

Local Community Member Travelers:

- a. Travel is permitted for medical reasons to Bethel and subsistence activities for the community members but are to take precautionary measures. Remember to follow the 6 feet social distancing.
2. 14 day self-quarantine requirement for individuals that travel out from the community to Anchorage area is to be followed by all until further notice. This includes all family members that reside in the same household.
 3. The no social gatherings held for the Tuntutuliak Traditional Council still stands until further notice. Limit gathering of more than 10 people. Stay 6 feet away from others in public places.
 4. Anyone that is sick (coughing, sore throat, fevers) are to stay home to prevent the spread of the flu/virus.
 5. Curfew for school age children is at 9:00 pm every night including weekends until further notice. Parents are encouraged to enforce the curfew hours to their children.
 6. Visitation to other households allowed as of May 5, 2020. The gathering of 10 or more people is still restricted until further notice. This is for the protection of the virus spreading.

7. The community building is now open to the public but you are to call in before going over.
8. Local clinic will be in operation under the discretion of Yukon Kuskokwim Health Corporation.
9. Local churches will be in service under the discretions of the church leaders but following the social distancing procedures.
10. As a reminder, ALCOHOL is prohibited within the Native Village of Tuntutuliak as it is a dry village. This is for the health and safety of our community members.

Tuntutuliak Traditional Council is looking after the well-being of our community. This is to protect the safety of our people. This emergency precautionary action will be updated periodically as needed.
