**EFFECTIVE OCTOBER 20, 2020 until further notice:** In an effort to slow or prevent the spread of the novel coronavirus disease 2019 (COVID-19) within our community, the City of Marshall, Native Village of Marshall, and Ohogamiut Traditional Council, the three governing bodies of Marshall, Alaska, hereby authorize the Native Village of Marshall- Beach Patrol to enforce the following local mandates:

1. Official community-level announcements regarding Covid-19 are to be made by the Public Information Officer (PIO) only.
2. The Agnes Boliver Memorial Health Clinic will operate at the discretion of the Yukon-Kuskokwim Health Corporation. Marshall Clinic (907) 679-6226
3. **RESIDENTS OF MARSHALL: IF YOU HAVE A FEVER, COUGH, OR SHORTNESS OF BREATH, CALL THE MARSHALL CLINIC AT (907) 679-6226, OR BETHEL HOSPITAL AT (907) 543-6949. DO NOT GO TO THE CLINIC UNTIL TOLD TO DO SO. DO NOT GO TO THE HEALTH AIDE'S HOME RESIDENCE TO REQUEST TESTING. STAY HOME UNTIL NOTIFIED BY THE CLINIC OR HOSPITAL.**
4. All gatherings, including: weddings, funerals, birthday parties, etc., are limited to resident access only. All gatherings that take place in enclosed spaces are required the use of face masks.
5. Essential travel for critical infrastructure or medical care is permitted. Anyone traveling to Marshall must notify the Native Village of Marshall-Beach Patrol. All non-residents entering Marshall under essential travel are required to wear face masks at all times and must avoid direct contact with residents.

6. Nonessential travel is prohibited.
7. For contact tracing purposes, the Native Village of Marshall-Beach Patrol will monitor the beach and airport landings and record the name of every person entering Marshall.
8. All residents returning to Marshall must self-quarantine for a period of 14 days or until a negative test result is verified by the Native Village of Marshall-Beach Patrol. Every person that resides in a household of an individual who has returned to Marshall must wear a face mask in any public setting until a negative test result of the individual is verified.
9. Retail businesses are required the use of face masks and are allowed a maximum of 10 customers at a time.
10. Private food sales are prohibited.
11. All public offices will remain open to the general public. Please call for office procedures regarding the use of face masks.





WE ARE ALSO ASKING TO KEEP SOCIAL DISTANCING FROM THE COMMUNITY. **THIS IS FOR THE SAFETY OF OUR TRIBAL MEMBERS, ESPECIALLY FOR OUR ELDERS, INFANTS AND MEMBERS WITH HEALTH ISSUES.**
